The substantive change, i.e., transfer of sponsorship from Emory Decatur Hospital to Emory University School of Medicine-Woodruff Circle for the certificate radiography program was considered at the May 19, 2025 meeting of the Joint Review Committee on Education in Radiologic Technology (JRCERT). The JRCERT is the only agency recognized by the United States Department of Education (USDE) and the Council for Higher Education Accreditation (CHEA) for the accreditation of traditional and distance delivery educational programs in radiography, radiation therapy, magnetic resonance, and medical dosimetry. Specialized accreditation awarded by the JRCERT offers institutions significant value by providing peer evaluation and by assuring the public of quality professional education in the radiologic sciences. The JRCERT took the following action:

APPROVAL OF TRANSFER OF SPONSORSHIP.

This substantive change was effective May 19, 2025.

The next site visit is scheduled for June 16-17, 2025.

The program is advised that consistent with JRCERT Policy 11.600, the JRCERT reserves the right to conduct unannounced site visits of accredited programs. The sponsoring institution would be responsible for the expenses of any onsite evaluation.

A revised Certificate of Accreditation will be provided along with Certificates of Recognition for the program's clinical settings. These certificates will be generated electronically and emailed in the near future.
